## AFFIDAVIT OF PROBABLE CAUSE

Comes now, the affiant, Deputy Eric VanBuskirk a sworn law enforcement officer, who personally appeared before a notary public or certified officer, makes this affidavit, which has been electronically submitted to the Court. The affiant swears under oath that he has probable cause to believe that certain laws have been violated in Lake County, Florida and that on or about July 14, 2017, Angel King did commit 7 seven counts of Cruelty to Animals 828.12(2).

- 1. That the events hereinafter set forth occurred at 35403 Huff Road, Eustis, in Lake County.
- 2. That Angel King is the self proclaimed proprietor of "Kings Cove Horse Rescue" and was in care of horses 1 through 7.
- 3. That Angel King failed to provide horses 1 through 7 the necessary food, nutrition, and care.
- 4. That as a result of Angel King's inaction of care, horses 1 through 7 began to starve. Their bodies first using fat reserves progressing to muscle degeneration to fuel their bodies requirement for food and nutrients.
- 5. That based on the Henneke Body Condition Score (BCS) which rates a healthy horse at a 9, which all impounded horses rated by, Lake County Veterinarian, Dr. Burba, scored well under.
- 6. That horse number one has a body condition score of 2 which is emaciated.
- 7. That horse number two has body condition score of 1 which is very emaciated.
- 8. That horse number three has a body condition score of 2 which is emaciated.
- 9. That horse number four has a body condition score of 2 which is emaciated.
- 10. That horse number five has a body condition score of 2 which is emaciated.
- 11. That horse number six has a body condition score of 0 (a body condition score of 1 is very emaciated) this horse has starved to the point it appears its skin is stretched over its bone structure.
- 12. That horse number seven has a body condition score of 0 (a body condition score of 1 is very emaciated) this horse has starved to the point it appears its skin is stretched over its bone structure.

- 13. That starvation over time is a repeated infliction of unnecessary pain and/or suffering.
- 14. That the Lake County Sheriff's Office Ag/Marine Unit has investigated three previous allegations of cruelty to animals due to the conditions of the horses beginning June 01, 2016.
- 15. That the horses have deteriorated since the initial investigation by the Lake County Sheriff's Office.
- 16. That the hooves of horses 1 through 7 have gone untended for long the term, causing them to become soft and begin to decay. (It is necessary to trim horse's hooves of excess material and clean the frog (center area of the hoof). If this is not done the hoofs will over grow causing posture issues for the animals which is painful.
- 17. That on July 16, 2017 DVM David Burba conducted a thorough exam of horses 1 through 7.
- 18. That from DVM David Burba's exam initially concluded that the condition of horses 1 through 7 is not attributed to age nor to obvious illness but is due to being deprived adequate food and nutrition.

Your Affiant believes that probable cause exists for the arrest of Angel King for seven (7) counts of Cruelty to Animals.
