 Before Me. the undersigned authority personally appeared D/S Z. SULLIVAN 2701 who being duly sworn, alleges, on information and belief, that on the 18TH day of JAN, 2019, in LAKE County, Florida, the defendant did:

DID COMMIT THE OFFENSE OF:

- POSSESSION OF METHAMPHETAMINE 893.13(6)(A)
- POSSESSION OF MARIJUANA LESS THAN 20 GRAMS 893.13(6)(B)
- THREE COUNTS OF DRUG PARAPHERNALIA 893.147(1)
- ATTACHED TAG NOT ASSIGNED 320.261
- DRIVING ON REVOKED SUSPENDED LICENSED DUI 322.34(2)(B)

On 01/17/19 at approximately 2353 hours, while on routine patrol while traveling southbound on State road 19 in Altoona, Florida, I approached the intersection of state road 19 and county road 42 at a red light. As I stopped my marked patrol vehicle at the red light I observed a black Chevrolet pickup truck travelling north bound on SR 19. As the vehicle approached the red light, it passed completely over the stop bar, stopping in the middle of the intersection, before accelerating east bound on CR 42. I immediately turned left traveling east bound on CR 42 where I activating my emergency lights on the black Chevrolet pickup truck bearing Florida tag N94OBM. When running the tag through NCIC/FCIC, which revealed the tag had expired in 2011, and was assigned to a GMC pickup truck.

The vehicle pulled into a Circle K gas located at 42404 SR 19. Upon making contact with the driver, (Arrestee) Jerry Johnson, I asked him for his drivers license, at which time he advised "I do not have a drivers license." I asked Mr. Johnson "Why don't you have a Florida Drivers License?" at which time Mr. Johnson stated it was suspended for DUI and has been suspended for approximately the last four years.

I then asked Mr. Johnson to exit the vehicle. Mr. Johnson exited the vehicle, and at which time he was taken into custody and placed into handcuffs for

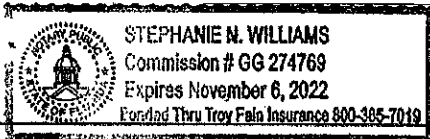

Before Me, the undersigned authority personally appeared D/S Z. SULLIVAN 2701 who being duly sworn, alleges, on information and belief, that on the 18TH day of JAN, 2019, in LAKE County, Florida, the defendant did:

driving on a suspended drivers license for DUI.

I then asked Mr. Johnson if there was anything illegal in the vehicle, at which time he stated "no." I then asked him for consent to search the vehicle, at which time he gave me verbal consent. I then asked the male and female passenger to exit the vehicle, at which time they were patted down for weapons after giving me consent to pat them down.

While searching the vehicle I located a clear smoking device under the passenger seat. I then asked Mr. Johnson who's smoking device is this and at which time he stated "it's mine and must have fell out of my pocket, and rolled underneath the passenger seat." I then proceeded to the driver side of the vehicle, where I located green and silver bb gun with laser in the door console. Underneath the driver seat I located another clear glass smoking device, and a black and blue zip up folder.

I then opened the folder and located two separate baggies of green leafy substance, a digital scale, approximately fifteen hundred dollars (\$1,500) cash, and a small plastic baggie containing crystal like substance, through my training and experience which I know to be methamphetamine, which field tested positive for methamphetamine. The green leafy substance, through my training and experience which I know to be marijuana, was fielded tested positive for marijuana.

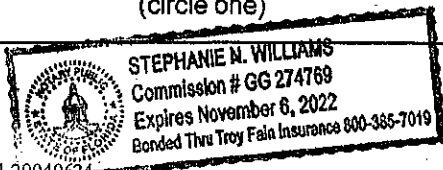

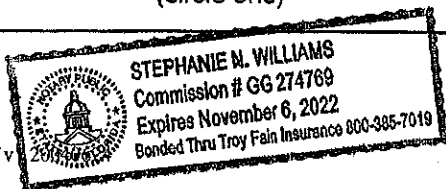
