I then proceeded to the driver side of the vehicle, where I located green and silver bb gun with laser in the door console. Underneath the driver seat I located another clear glass smoking device, and a black and blue zip up folder.

I then opened the folder and located two separate baggies of green leafy substance, a digital scale, approximately fifteen hundred dollars (\$1,500) cash, and a small plastic baggie containing crystal like substance, through my training and experience which I know to be methamphetamine, which field tested positive for methamphetamine. The green leafy substance, through my training and experience which I know to be marijuana, was fielded tested positive for marijuana.
