 Before Me, the undersigned authority personally appeared \_\_\_\_\_ who being duly sworn, alleges, on information and belief, that on the 09 day of 09, 2019, in LAKE County, Florida, the defendant did:

Commit Criminal Solicitation for Murder F.S.S.777.04 (4B).

That LCSO SRD was contacted by a juvenile witness (Witness 1) advising the juvenile defendant had given her friend, another documented witness (Witness 2), "a lot of money" to find someone to kill her parents.

That an investigation revealed that the juvenile defendant had stolen her parents debit card and completed two transactions one for \$503.00 and one for \$926.40, later identified as money given to two different individuals to kill her parents. Juvenile defendant was arrested by Umatilla PD regarding the theft UPD Case # 19UM4441

I Detective Causey made contact with juvenile defendants boyfriend who advised he had seen the juvenile defendant in the early morning of 9/9/19 at a known drug house where she advised him she wanted to kill her parents.

That I Detective Causey made contact with juvenile Defendant at her residence where she advised in a recorded interview that she had stolen her parents debit card and had made the two transactions mentioned above. The juvenile defendant elaborated that \$100 was used to buy cocaine and the \$400 was given to her friend (Witness 2) to give to someone to kill her parents. Juvenile defendant continued advising since the act was never carried out she gave the other \$900 to a black male to kill her parents. Juvenile defendant provided an affidavit stating the above.

That the victims, parents of juvenile defendant, advised their intent to persecute for the charge of Criminal Solicitation for Murder F.S.S.777.04 (4B).

At the Umatilla Police Department, D.J.J. was contacted and made aware of the above listed incident.
